#### **Preamble**

1.8

(1) Pursuant to Paragraph v) of Subsection (2) of Section 2 of the Admission Regulation" (hereinafter: AR), the following rules are hereby issued for the 2025 central admission procedure.

#### Scope

2.8

- (1) The personal scope of the present provisions of the VRAP shall cover:
  - a) applicants applying for admission to the Corvinus University of Budapest (hereinafter: University) for bachelor, single-cycle and master programmes under the 2025 central admission procedure.
  - b) persons, organisational units and bodies involved in admission matters.

#### **Definitions**

3.8

(1) The terms used in these Provisions shall have the meanings given to them in Section 3 of the AR and in Section 3 of the Study and Examination Regulations.

#### Entitlements for institutional points in the admission procedure

4.8

(1) Under the 2025 central admission procedure, entitlements for institutional points for bachelor and single-cycle study programmes are set out in 5(3) of Annex 2 to the Admission Regulation constituting Part 1 of the Student Requirements.

#### b) Supporting document:

Proof of language proficiency can be provided by a language examination certificate recognised by the state or equivalent document, such as:

- a decision on the nostrification/recognition in Hungary of the language examination certificate issued abroad,
- a certificate of secondary education or higher education obtained abroad in a staterecognised institution,
- an appropriate secondary school-leaving certificate from a national minority secondary school, etc.

Oral (formerly type A) and written (formerly type B) language examination certificates in the same language at the same level are automatically considered complex (formerly type C). If an applicant records information on oral (formerly type A) and written (formerly type B) examination certificates of two different levels, the lower level may be taken into account.

A partial monolingual written/oral language examination certificate and a partial bilingual written/oral language examination certificate in the same language and at the same level are together considered to be a monolingual complex language certificate. The combination of partial monolingual and bilingual language examination certificates is governed by the previous Subsection.

For language for special purposes examination certificates, the recognition of oral and written language examination certificates as complex language examination certificates is not automatic, as only partial language for special purposes examination certificates with the same content may be combined.

An official certificate of combinability issued by the Language Examination Accreditation Department of the Educational Authority (Nyelvizsgáztatási Akkreditációs Központ in Hungarian, hereinafter: NYAK) may be accepted for the procedure.

Correction of incorrect data on the certificate:

If the language examination certificate contains incorrect data (e.g. incorrect place of birth or two first names), the NYAK will issue an official certificate within 8 days on request to the NYAK, free of charge, which the applicant shall upload to the electronic admission interface (e-felvételi in Hungarian).

The Education Authority only has an official public register of state-recognised language examinations taken after 1 January 2000, and can only check data discrepancies and issue any certificates related to language examinations for state-recognised language examinations taken after 1 January 2000.

If the language examination certificate has been lost, the NYAK will issue an official certificate at the applicant's request, attesting to the fact that the language examination certificate in question was obtained.

Provision of language examination data:

During the higher education admission procedure, the authenticity of state-recognised language examination certificates shall be checked on the basis of mandatory data (language, level, type, certificate number, registration number and date of issue).

A certificate of successful language examination issued by the accredited examination centre or examination venue organising the examination shall not be accepted as a language examination certificate. The NYAK will not issue a certificate of successful language examination before the certificate is printed.

The official documents, certificates and nostrification decisions issued by the NYAK attesting the level of language proficiency are also equivalent to a language examination certificate, so it is not mandatory to submit the document on which they are based.

The various documents issued by language examination centres do not certify the existence of a language examination certificate in the admission procedure. The NYAK issues a so-called information document on the documents certifying successful examination equivalent to the state language examination listed in the annex of Decree No. 3/1980 (25 October) of the Minister of Labour on the state language examination to demonstrate foreign language skills as well as language examination certificates, if the exam was passed on the basis of a legal relationship entered into after 31 December 1950 and before 31 December 1999.

The rigorosum, final examination, interpreter diploma, etc. in the annex of the Decree above may entitle its holder to institutional points in combination with the information document issued by the NYAK. If the information document is submitted, it is not necessary to send the document on which it is based. If you do not have the NYAK information document, you shall send a copy of the pages of the transcript containing your personal data and details of the programme (name of the programme, mode of study, etc.).

Language examination certificates obtained in another country:

Language examination certificates obtained in another country may only be taken into account in the admission procedure if they have been nostrified by the NYAK or, before 2000, by the State Language Examination Board and a decision has been made on this.

An exception to this, i.e. no nostrification is required, are the following language examination certificates that are equivalent to Hungarian language examination certificates under international cultural conventions

- Language examination certificates obtained in the Cambridge Assessment English foreign language examination, if obtained after 24 December 2020, and
- language examination certificates obtained in the Goethe Institut foreign language examination system, if the applicant has obtained it after 2 October 2021.

Language examination certificates based on a Hungarian secondary school-leaving certificate/attestation:

Secondary school-leaving certificates obtained in secondary schools with two languages of instruction or national minority schools are considered equivalent to language examination certificates under the conditions set out in Section 54 of Government Decree No. 100/1997 (13 June) and certify specific language proficiency.

Advanced level secondary school-leaving examination, passed with at least 60%, in a foreign language or in national minority education involving foreign language teaching, which is included in the secondary school-leaving certificate or attestation, shall qualify as a level B2 (formerly intermediate) complex (formerly type C) language examination certificate, under the conditions set out in the examination regulation.

Language examination certificate on the basis of a secondary school-leaving certificate obtained abroad:

A secondary school-leaving certificate from a foreign secondary school with Hungarian as the language of instruction shall qualify as a level B2 (formerly intermediate level) complex language examination certificate in the language of the country. If the applicant submits an official certificate (with proper heading, signature, stamp and date) issued by a secondary school with Hungarian as the language of instruction stating that the applicant studied at least one subject<sup>1</sup> in the language of its country for at least two years, his/her secondary school-leaving certificate is equivalent to a level C1 (formerly advanced level) complex language examination certificate in the language of that country.

If the language of instruction is mentioned in the foreign secondary school-leaving certificate or its annex, the correspondence with the level of the language examination certificate shall be established according to the language of instruction mentioned in the certificate. If the language of instruction for all subjects is Hungarian, school certificates on other languages may not be accepted and the secondary school-leaving certificate is equivalent to a level B2 (formerly intermediate) language examination certificates.

cate. In order to recognise it as a level C1 (formerly advanced level) language examination certificate, the applicant shall submit all pages of his/her foreign secondary school-leaving certificate, including the annex.

A secondary school-leaving certificate from a state-recognised foreign secondary education institution attesting to studies in a foreign language, i.e. a language other than Hungarian, is equivalent to a state-recognised, general, monolingual, complex and level C1 (formerly advanced level) language examination certificate in the language of instruction.

An institutional point may therefore be awarded if the applicant has studied in a language other than Hungarian. Institutional points for languages may only be awarded on the basis of documents proving secondary education, which can be considered equivalent to a Hungarian school-leaving certificate and which have been uploaded in full.

Primary school certificates are not acceptable in the admission procedure, because according to Subsection (9) of Section 14 of Government Decree No. 137/2008 (16 May) on the certified examination of foreign language attainment and on the nostrification in the Republic of Hungary of language certificates of foreign language attainment issued abroad, only studies at a foreign educational institution when successfully completed (certified by a secondary school-leaving certificate) may be certified.

Language examination certificate on the basis of a Hungarian diploma:

Only the following diplomas obtained from a Hungarian higher education institution may be recognised as a general bilingual complex level C1 (advanced level) language examination certificate recognised by the state:

- diploma from a faculty of arts in modern or classical languages,
- teacher's and language teacher's diploma in modern or classical languages and literature, teachers' diploma with an MA in foreign languages,
- school teacher's diploma in the field of foreign languages,
- national minority teacher's, national minority schoolteacher's or national minority kindergarten teacher's diploma,
- and diploma or certificate of qualification issued upon the completion of a special translators' or special translators' and interpreters' course,

A bachelor diploma in a foreign language from a faculty of arts, which certifies a professional qualification in a foreign language, is equivalent to a state-recognised, bilingual, complex and level C1 (advanced level) language examination certificate for the language indicated in the qualification. A bachelor diploma from a faculty or arts, which indicates a specialisation in a foreign language, is equivalent to a general bilingual complex language examination certificate at the level corresponding to the outcome level in terms of languages as specified in the programme and outcome requirements.

A diploma attesting to studies pursued and completed in a foreign language is equivalent to a state-recognised, monolingual, complex C1 type (advanced) language examination certificate in the language of instruction.

A diploma and certificate issued upon the completion of a special translators' or special translators' and interpreters' course qualify as state-recognised complex C1 type (advanced) language examinations for special purposes regarding the language studied. Master-level translators' and interpreters' diplomas are, regarding the language studied, equivalent to state-recognised general, bilingual and complex level C1 (advanced) language exams.

Language examination certificate based on a foreign diploma:

A diploma obtained at a state-recognised higher education institution abroad which attest to tertiary education, regarding the language of instruction, is equivalent to a state-recognised general monolingual complex C1 type (advanced) language examination certificate if the applicant has pursued his/her studies in a language other than Hungarian and he/she can produce documentary evidence thereof.

Other rules for recognising attainments as language examination certificates:

A diploma from a faculty of arts obtained at a higher education institution abroad in modern or classical languages, a teacher's and language teacher's degree in modern or classical languages and literature, a teachers' degree with an MA in foreign languages are equivalent to a state-recognised general complex C1 type (advanced) language examination, but only for the foreign language studied.

A certificate issued by the higher education institution or the diploma supplement is required for recognition as a language examination certificate and for the identification of the language of instruction. If the language of instruction cannot be clearly established from the documents submitted (diploma, certificate, diploma supplement) or due to their absence, no institutional points for language examination certificates can be awarded for the tertiary diploma.

- c) Rules for submission: Documents supporting entitlement shall be uploaded to the Educational Authority's electronic admission system (e-felvételi in Hungarian).

  There is no need to upload state-recognised language examination certificates obtained in Hungary, as these results are automatically retrieved from an official public register.
- (2) Proof of advanced-level secondary school-leaving examination:
  - a) Supporting document: secondary school leaving certificate/diploma
  - b) Rules for submission: Documents supporting entitlement shall be uploaded to the Educational Authority's electronic admission system (e-felvételi in Hungarian).

There is no need to upload Hungarian secondary school-leaving certificates and school-leaving attestations issued in Hungary after 1 January 2006, because these results are automatically obtained from an official public register.

- (3) International Baccalaureate (IB) diploma:
  - a) Supporting document: international baccalaureate diploma
  - b) Rules for submission: Documents supporting entitlement shall be uploaded to the Educational Authority's electronic admission system (e-felvételi in Hungarian).
- (4) Documents for equal opportunities
  - a) Types of equal opportunities: disability, disadvantage, childcare
  - b) Method of certification: in case of disability
    - The applicant's disability or special educational needs can only be confirmed by a detailed expert opinion.
    - ba) The type of disability of the student (applicant) with a disability shall be certified by an expert opinion issued by the body specified in (bb).
    - bb) If the student (applicant) with disability for who:
      - 1) the disability or special educational needs existed already during secondary education, the disability or special educational needs can be confirmed by an expert opinion issued by the county (capital) pedagogical specialised service institutions and their member institutions acting as a county expert committee;
      - 2) the disability or special educational needs did not exist during secondary education, the disability that arose afterwards can be certified with an expert opinion issued by the ELTE National Pedagogical Professional Service (hereinafter: ELTE GYOPSZ).
    - bc) If the applicant is not a Hungarian national and does not have a place of residence, or a place of stay in Hungary, the disability may be proved by a certified translation of an expert opinion issued abroad, notwithstanding subparagraph (bb). Corvinus publishes on its website a list of languages for which it accepts non-certified translations.
    - bd) Applicants or students who are not Hungarian nationals and who are not studying at the University on the basis of a cooperation agreement between Corvinus and the sending university and who have an expert opinion issued abroad, may prove their disability by providing a certified translation of the expert opinion issued abroad, notwithstanding subparagraph (bb). Corvinus publishes on its website a list of languages for which it accepts non-certified translations.
    - be) By way of derogation from subparagraphs (bc)-(bd), if a student who is not a Hungarian national or a student with a place of residence or a place of stay abroad does not have an original expert opinion issued by a foreign professional authority, he/she

may prove the type of his/her disability by an expert opinion issued by the body specified in subparagraph (bb).

The expert opinion must always include the name of the disability and/or its BNO code. Failing this, the document will not be accepted. If the expert opinion contains a reference to a review, the expert opinion (addendum, amendment) of the review must also be submitted. However, the addition or amendment can only be accepted together with the detailed expert opinion. The entitlement must apply for the period between the publication of the Higher Education Admission Bulletin and 9 July 2025. (This date is not the same as the date of issue of the document.)

An extract, summary expert opinion, supplementary expert opinion or certificate from the issuing body alone is not acceptable as proof of disability, even if it would otherwise be (formally) appropriate. Nor can a preliminary expert opinion be accepted, as it only provides information on the expected content of the final expert opinion, which can still be appealed by the parent or pupil of legal age. If the applicant's disability or special educational need(s) already exist(s) during secondary education, the disability or special educational need can be confirmed by a detailed expert opinion. Pursuant to Decree No. 15/2013 (26 February) of the Minister of Human Capacities on the functioning of pedagogical professional services, the expert report shall be prepared by the expert committee of the county (capital) pedagogical service (or their member institutions acting as county or national expert committees) in the context of expert committee activities. (Of the legal predecessors of the pedagogical services, the expert and rehabilitation committees for learning ability and the national expert and rehabilitation committees may issue expert opinions.)

Students (applicants) who did not have a disability or special educational needs during their secondary education may apply for a disability assessment from the ELTE National Pedagogical Professional Service after 1 September 2020. Expert opinions issued by the predecessors of rehabilitation administrative bodies (e.g. metropolitan and county government offices, NRSZH, OOSZI, etc.) and final (i.e. without a review period) are of course still acceptable.

Certificates, decisions and other documents issued by the following organisations are not acceptable either: Authority positions and official certificates, because they only contain the extent of the impairment, not the name of the disability. Expert opinions issued by the county (capital city) pedagogical services on integration, learning and behavioural difficulties, and previously issued by educational counsellors. Expert opinions, extracts of expert opinions and certificates issued by a forensic expert (if issued after 1 January 2008). Chief specialist's medical opinion (if issued after 1 January 2008). Outpatient card, hospital discharge report, specialist medical certificate, medical record, referral. Other certificates with medical signature and stamp (e.g. Hungarian State Treasury, Regional State Treasury Office, National Health Insurance

Fund, etc.). Secondary school decisions on exemption from studying a subject. A decision issued by a higher education institution exempting the applicant from taking a state-recognised language examination on the grounds of disability. Medical records, patient's charts and other certificates issued by psychiatric hospitals, the Hungarian Autism Foundation (and Research Group), the Vadaskert Hospital and the Budapest Early Development Centre. Decision on invalidity allowance, because it does not specify the disability, only a reference to the decision of the National Office for Rehabilitation and Social Affairs or its predecessors. Decisions on blind persons' allowance, because they do not specify the disability, only a reference to the decision of the National Office for Rehabilitation and Social Affairs and its predecessors. Official cards (blind, disabled or deaf persons' card). Documents issued by speech and language therapy institutes. Certificates issued by the Demosthenes Foundation. Certificates of the Meixner Foundation. Bank statements for disability allowance, blind persons' allowance or so-called "pink payment orders". Payment receipts, tax documents or certificates for tax relief. Fully subsidised public healthcare certificate. Expert opinions of speech improvement institutes. Official certificates issued by the Hungarian State Treasury (MÁK) or the National Health Insurance Fund (OEP) on the increased amount of family allowance. Certificates from the general practitioner. The audiogram and the recommendation to wear a hearing aid.

#### c) Method of certification: in case of disadvantaged status

A certificate or a decision of the notary or the competent guardianship authority may be accepted as proof of disadvantaged status. If it establishes only a regular child protection benefit, it cannot be accepted as a proof of disadvantaged status on its own under Section 67/A of Act XXXI of 1997.

The entitlement must apply for a period between the publication of the Higher Education Admission Bulletin and 9 July 2025.
