

# The Corvinus University of Budapest

invites applications for the 1st and 2nd semesters of the 2025/2026 academic year in accordance with the Regulation on Student Fees and Benefits (hereinafter: RSFB) constituting Part 4 of the Student Requirements and the Regulation on Study Abroad (hereinafter: RSA) constituting Part 9 of the Student Requirements

## **Within the framework of student mobility For participation in a study abroad programme and for the Pannonia Scholarship for Excellence to support participation**

The aim of the call for application is to enable students achieving outstanding performances - who are able to perform well at those partner universities of the Corvinus University of Budapest (hereinafter: University) that are on the top of international rankings - to participate in mobility programmes most suitable for them, thus broadening their horizons, deepening their professional knowledge and building international contacts with their fellow students abroad, which will foster their future professional lives, too.

### **1. The call for applications applies to**

- 1.1. student participation in the University's Pannonia Scholarship for Excellence, a learning mobility programme of 1-6 months, provided that the destination of the mobility is one of the top 250 foreign higher education institutions in the Times Higher Education or the Quacquarelli Symonds international higher education rankings. (Annex 1)

### **2. Legal and regulatory background to the call**

The general rules for participation in mobility programmes are set out in the RSA within the University, and, for students attending doctoral programmes, in the Doctoral (PhD) Regulations and the operating rules of the relevant doctoral schools.

In addition to the above, the following university and non-university regulations and other rules apply to the individual programmes:

- 2.1. the Pannonia Scholarship Programme International Mobility Programme Implementation Guide and the grant contract between Corvinus University of Budapest and Tempus Közalapítvány (Tempus Public Foundation).
- 2.2. The rules for credit recognition are set out in the Study and Examination Regulations (SER), and in the case of doctoral students, in the Doctoral (PhD) Regulation and the operating rules of the relevant doctoral school.

### **3. Criteria for submitting the application and granting the scholarship:**

- 3.1. Applications may be submitted by students attending two-cycle or single-cycle Master programmes or doctoral programmes at the University, regardless of the mode of study, who meet the following conditions:
  - 3.1.1. the destination of the mobility is one of the top 250 higher education institutions in the Times Higher Education or the Quacquarelli Symonds international higher education rankings (Annex 1), and the institution declares that it will host the students and allow them to take courses, even if there is no bilateral agreement with the University in place yet for the implementation of international mobility;
  - 3.1.2. have completed at least 1 semester in the case of Master and doctoral programmes, and at least 7 semesters in the case of single-cycle programmes, by the end of the 1st (autumn) semester of the 2024/2025 academic year.
  - 3.1.3. in the programme affected by the call for applications, at the end of the 1st (autumn) semester of the 2024/2025 academic year, have a cumulative average academic performance of minimum 4.50 or above or the cumulative academic performance required by the receiving institution;
  - 3.1.4. at the time of submitting their application, have at least a C1 level complex language examination in the language of the intended studies, and submit the relevant certificate of this as an annex to their application;
  - 3.1.5. do not benefit from a Stipendium Hungaricum or Diaspora scholarship to cover their programme costs;
  - 3.1.6. students attending two-cycle or single-cycle Master programmes declare that at the time of starting their studies abroad, they still have to earn at least 21 credits to obtain the absolutorium, but the 21 credits may not include the mandatory practice period and the thesis seminar,
  - 3.1.7. for Ph.D students, the number of credits awarded by the receiving institution abroad may not exceed the maximum number of credits specified in the Doctoral (PhD) Regulation and the rules of operation of the relevant doctoral school
  - 3.1.8. only students who undertake to be active students at the University during the semester of the mobility abroad may participate in mobility programmes.
- 3.2. Other conditions of submitting the application and participating in the programme:
  - 3.2.1. To be eligible for the long-term excellence mobility programme, students must have at least 1 completed semester in the case of Master and doctoral programmes, and at least 7 completed semesters in the case of single-cycle programmes at the University, at the start of their mobility.
  - 3.2.2. In their applications, students may only select institutions that offer topic areas related to the programme affected by the application (see Annex 5 for the topic areas that may be selected for individual programmes).
  - 3.2.3. Students attending more than one programmes at the same time must specify in their applications from which programme they are applying for the mobility programme, and only their academic performance in relation to the programme selected that way will be taken into account in the assessment of their application (number of semesters completed, academic performance), and they may select partner institutions related to this field of study only in their application.

- 3.2.4. In the case of learning mobility, only the following activities carried out abroad may be accepted: full-time, daytime studies in a two-cycle or single cycle Master programme or doctoral programme leading to a recognised diploma or degree. The programme supports only physical mobility based on actual travel, virtual activities are not eligible for support. Learning mobility is available for compulsory, compulsory elective and elective subjects, but mobility programmes are not available for the sole purpose of preparing a thesis, including the completion of a thesis seminar, or for the completion of criterion subjects.
- 3.2.5. In their application, applicants must establish a preference ranking of minimum one and maximum six institutions from among those listed in Annex 1, indicating the topic area of the programme and the expected duration of the trip (duration of study). The order of preference and the selected period of studies cannot be revised after the first step of the application process (see point 4.1).
- 3.2.6. Before submitting their applications, applicants must make sure that the institution they wish to apply to is able to receive them for the study abroad programme, and does not have any requirements that would prevent them from studying abroad (e.g. language examination requirements that exceed the minimum criteria, i.e. complex C1 language examination in the language of studies).
- 3.2.7. It is the responsibility of the applying student to check the subjects offered by the universities for the period applied for and the language of instruction for the subjects before submitting the application. If the subjects offered for the mobility semester are not available during the application period, information can be collected based on the subjects offered in previous semesters.
- 3.2.8. It is the student's responsibility to check the acceptance of the subjects offered by the partner universities before submitting the application, in view of the fact that the subjects completed at the partner institution must be accepted at the University.
- 3.2.9. If the applicant requests that other activities included in the evaluation criteria be taken into account in his/her application, he/she must attach the relevant certificates signed by the persons specified in the RSFB, as set out in the table in Annex 2. **Only** documents in **pdf** format can be attached to the application.
- 3.2.10. In the case of the excellence scholarship programme, it is possible to implement learning mobility as mixed mobility, i.e. study in a way that a part of the mobility is online/virtual, and only a certain part of the learning mobility involves actual physical mobility. Mixed mobility has a mandatory physical component, studies without actual physical mobility cannot be considered as mixed mobility.  
The following rules apply to such mixed mobility:
- 3.2.10.1. Students are entitled to a scholarship for the duration of their physical mobility.
- 3.2.10.2. Students are entitled to housing and travel support for the duration of their physical mobility.
- 3.2.10.3. In the case of mixed mobility of more than 6 months, tuition fees may be subsidised on a pro rata basis up to a maximum of 6 months.

3.3. In addition to the above, there are special rules for students attending PhD programmes:

3.3.1. Students participating in a PhD programme may only apply to a partner university from which they have an official letter of acceptance or a clear written confirmation of their acceptance, agreed in advance and documented by the collaborating partner (the lecturer or researcher who is affiliated to the institution).

3.3.2. they must attach to their application a signed detailed research plan and work plan with the requirements set out in Annex 4 to this call for applications.

#### 4. Method of submitting applications

The application (including the name of the institutions and the application form) must be submitted in the Neptun study system as follows:

4.1. In the first step, in the Neptun/Administration/Erasmus menu, students indicate all the institutions, the topic areas belonging to the institutions and the expected start date and duration of the studies for which they wish to apply (order of preference). A maximum of 6 institutions from the list in Annex 1 can be selected for this excellence call for application. **The interface where the institutions can be selected and the final order of preference can be determined will be open from 10:00, 20 January 2025 to 10:00, 27 January 2025.** The selection of the institutions does not constitute an application, but it is a condition for a valid application.

4.2. In the second step, based on the order established and finalised in the previous step, students can submit their applications for the study abroad programme and for the excellence scholarship supporting their study abroad (E402 - Study Abroad, Excellence Mobility) in Neptun/Administration/Applications. **The application period is 09:00, 28 January 2025 - 15:00, 3 February 2025.** Applications may be submitted by students who have made their choice from among the eligible institutions as described in the previous point. The application is valid only for the institutions identified and ranked in accordance with the previous point.

4.3. **The two above activities (selection and prioritisation of institutions and submission of the application) together constitute the submission of an application according to this call for applications.**

4.4. The above deadlines are time-barred and late or incomplete applications will not be taken into account in the assessment. There is no room for correcting deficiencies or for submitting applications for justification.

#### 5. Evaluation of applications

5.1. Applications will be rejected without examining the merits from students who:

5.1.1. are not eligible to submit an application under the criteria set out in subsection 3;

5.1.2. if the student did not attach the mandatory document indicated as a condition for the submission of the application, or did not attach it in accordance with the content or form of the call for applications.

- 5.1.3. The student has not completed one of the activities under point 4 (selection of institutions and definition of order of preference and submission of application).
- 5.2. If the applicant does not provide the required certification for an activity specified in the call for applications, or does not provide it in accordance with the content or form specified in the call for applications, or if it is technically incorrect (e.g. the file cannot be opened), the given activity will not be evaluated, but the other elements of the application - if they are certified in accordance with the rules of the call for applications - will be evaluated.
- 5.3. Submitted applications will be assessed according to the criteria set out in Annex 2 for students attending two-cycle and single-cycle programmes.
- 5.4. For PhD students, the assessment will follow the rules set out in Annex 3.
- 5.5. Applicants who provide false or untrue information or make false or untrue declarations during the application procedure will be disqualified.

## 6. Ranking of applications

- 6.1. The currently available resources are allocated according to the following principles.
  - 6.1.1. Ranking and allocation of available resources based on the number of points calculated on the basis of the documents submitted by students and their other achievements.
  - 6.1.2. In the case of identical number of points, students with better academic performances (cumulative adjusted credit index) will receive grants.
- 6.2. In case of withdrawal, the grant will be awarded to the next student based on the number of points, in the order of priority.
- 6.3. Taking into account the aggregated number of points, the preference order indicated by applicants and the rules of ranking, the decision on the places of study abroad and the funding opportunities is taken by the Head of the International Mobility Programmes, who will issue his/her decision in a resolution.
- 6.4. The applicant must accept the higher education institution awarded on the basis of his/her number of points and preference list.

## 7. Funding components of the excellence scholarship programme

- 7.1. Support available under the excellence scholarship programme:
  - 7.1.1. scholarship
  - 7.1.2. housing allowance
  - 7.1.3. travel allowance
  - 7.1.4. tuition fee allowance
- 7.2. Tuition fee, housing and travel allowances provided under the excellence scholarship programme are settled **on the basis of the actual expenses incurred** and are due to the applicant for the duration of the physical mobility, as this is intended to cover all expenses incurred by the scholarship holder. In view of the above, the student must give an account of the allowances paid to him/her under these titles item by item.
- 7.3. The following supporting documents must be kept in relation to the use of the grant:
  - 7.3.1. In the case of travel allowance:

- 7.3.1.1. original invoices, receipts and other documents documenting the actual expenses of the trip,
- 7.3.1.2. travel documents (ticket, boarding pass etc.), based on which the travel date(s) can be determined
- 7.3.1.3. the contract signed with the student, based on which the allowance is paid
- 7.3.1.4. documents relating to the payment of the allowance
- 7.3.2. In the case of housing allowance:
  - 7.3.2.1. a copy of the contract signed with the provider of the facility, including the housing costs and the period of service used.
- 7.3.3. In the case of tuition fee allowance:
  - (1) the contract signed with the receiving institution, specifying the amount of tuition fees
  - (2) documents proving the payment of tuition fees
  - (3) the contract signed with the student, based on which the allowance is paid
  - (4) documents relating to the payment of the allowance
- 7.4. The amounts of support that may be claimed are set out in Annex 6
- 7.5. The target countries and groups of countries are listed in Annex 7

## **8. Legal remedy**

- 8.1. Applicants have the right to appeal against the decision of the Head of the International Mobility Programmes within 15 days from the date of notification or, failing that, from the date of learning about the decision, in accordance with Sections 57-58 of Act CCIV of 2011 on National Higher Education. Legal remedy requests must be submitted through Neptun, addressed to the Student Appeals Committee.
- 8.2. In the subject of the legal remedy request, the Student Appeals Committee will make a decision in a procedure for the assessment of first instance applications and legal remedy requests in relation to student status (hereinafter: SSP).
- 8.3. The time limit for administration is thirty (30) days, which does not include the periods specified in subsection 15 (3) of the SSP, especially the period in which administration at university level is suspended (i.e. the period of university shutdown).

## **9. Extension of the mobility period, multiple participation in mobility programme**

The excellence programme cannot be extended.

## ***Annex 2: Rules for the assessment of applications for learning mobility programmes for students in two-cycle or single-cycle Masters programmes***

Applications submitted for mobility programmes will be assessed as follows, on the basis of the following criteria. The maximum number of points is 14.

### **1) Points awarded on the basis of academic performance** (maximum 7 points)

1a) The average academic performance for completed semesters is the cumulative adjusted credit index, rounded to 2 decimal places.

1b) If the student does not have a completed semester before the semester of application, the points are calculated on the basis of his/her admission points (number of admission points without additional points):

### **2) Points awarded for scientific activity** (maximum 5 points)

Maximum 100 points can be awarded in the scientific assessment, and it will be converted into a 5-point system (points obtained /20)

Other professional activities of applicants attending Master programmes, related to their Bachelor programmes before their Master programmes and their Master programmes affected by the application, have to be evaluated as set out in the table below. Each activity must be supported by appropriate certifying documents (even if carried out at other higher education institutions) - in the lack of these, no points will be awarded.

If the student is applying with a co-authored TDK paper or other scientific work, the following scoring applies:

- a) if the paper has two authors, the applicant may receive 70% of the maximum number of achievable points,
- b) if the paper has more than two authors, the student may receive the maximum number of achievable points divided by the number of authors.

### **3) Points awarded according to ranking in own programme, cohort** (maximum 2 points)

The student is ranked in the top 30 per cent of the list created on the basis of the cumulative adjusted credit index of the number of students in the programme, cohort at the time of enrolment. 4 points can be awarded for that. If the top 30% cannot be decided (due to identical average), 1 point can be awarded.

- scholarship;
- tuition fee allowance (based on actual expenses incurred);
- travel allowance (based on actual expenses incurred);
- housing allowance (based on actual expenses incurred).

There is no upper limit on the amount of tuition fee, travel and housing allowances that can be granted to students, however, a maximum of HUF 10,000,000 can be provided for the above allowances in total for an excellence scholarship holder student, with the provision that the scholarship must be provided in any case to the student participating in the mobility for the duration of the physical mobility. Only one return journey between the registered seat of the sending institution or the place of residence of the person travelling and the city of the receiving institution is eligible for the travel allowance.
