invites applications for the 1st and 2nd semesters of the 2025/2026 academic year in accordance with the Regulation on Student Fees and Benefits (hereinafter: RSFB) constituting Part 4 of the Student Requirements and the Regulation on Study Abroad (hereinafter: RSA) constituting Part 9 of the Student Requirements

Within the framework of general, long-term learning mobility

For participation in a study abroad programme and

for a scholarship to support participation in a study abroad programme

The aim of the call for applications is to attract as many students as possible with excellent academic performances, who are able to perform well at the partner universities of the Corvinus University of Budapest (hereinafter: University), to participate in the learning mobility programmes most suitable for them, thus broadening their horizons, deepening their professional knowledge and building international contacts with their fellow students abroad, which will foster their future professional lives, too.

1. The call for applications applies to

- 1.1. **participation in** a long-term learning mobility programme run by the University, such as:
 - 1.1.1. The Pannonia Scholarship Programme and
 - 1.1.2. other programmes based on inter-institutional cooperation agreements, other than the Pannonia Scholarship Programme:
 - 1.1.2.1. CEMS
 - 1.1.2.2. QTEM
 - 1.1.2.3. double or multiple degree programmes,
 - 1.1.3. other programmes based on inter-institutional cooperation agreements not covered by points 1.1.1 and 1.1.2 (e.g. CEEPUS), and
- 1.2. to receive **financial support** (scholarship) for the participation opportunity applied for, regardless of whether the University provides the financial support through a grant from the Pannonia scholarship programme, funds provided by the Maintainer or other own income.

2. Legal and regulatory background to the grant

The general rules for participation in mobility programmes are set out in the RSA within the University, and, for students attending doctoral programmes, in the Doctoral (PhD) Regulation and the operating rules of the relevant doctoral schools.

In addition to the above, the following non-university regulations and other rules apply to the individual programmes:

- 2.1. For the Pannonia scholarship programme, the Pannonia Scholarship Programme International Mobility Programme Implementation Guide and the grant contract

- between Corvinus University of Budapest and Tempus Közalapítvány (Tempus Public Foundation).
- 2.2. other programmes based on inter-institutional cooperation agreements (bilateral or multilateral contracts) other than the Pannonia scholarship programme:
 - 2.2.1. In the case of CEMS, the rules of participation are defined by the common requirements set by the CEMS Association on the <https://cems.org/> website and the application criteria on the Corvinus website (for more information: [CEMS programme](#))
 - 2.2.2. In the case of QTEM, the rules of participation are defined by the common requirements set by the QTEM Association on the <https://www.qtem.org/> website and the application criteria on the Corvinus website (for more information: [QTEM programme](#))
 - 2.2.3. for double or multiple degree programmes, the cooperation agreements between the universities (for more information: [Double Degree Programmes](#))
 - 2.3. in the case of other programmes based on inter-institutional cooperation agreements (bilateral or multilateral contract) other than those referred to in point 1.1.3, the cooperation agreements concluded by the universities.

The rules for credit recognition are set out in the Study and Examination Regulations (SER), and in the case of doctoral students, in the Doctoral (PhD) Regulation and the operating rules of the relevant doctoral school.

3. Criteria for submitting the application and granting the scholarship:

- 3.1. Applications may be submitted by students attending Bachelor programmes, two-cycle or single-cycle Master programmes or doctoral programmes at the University, regardless of the mode of study, who meet the following conditions:
 - 3.1.1. in the programme affected by the call for applications, have a cumulative average academic performance of 3.00 or above at the end of the 1st (autumn) semester of the 2024/2025 academic year;
 - 3.1.2. at the time of submitting their application, have at least a B2 complex language examination in the language of the intended studies, and submit the relevant certificate as an annex to their application;
 - 3.1.3. if the selected partner university expects a higher level of language proficiency than the level specified in point 3.1.2, a valid document certifying this must be attached to the application;
 - 3.1.4. do not benefit from a Stipendium Hungaricum or Diaspora scholarship to cover their programme costs;
 - 3.1.5. agree to have at least one (1) completed semester at the University at the start of the mobility;
 - 3.1.6. students attending Bachelor or two-cycle or single-cycle Master programmes declare that at the time of starting their studies abroad, they still have to earn least 21 credits to obtain the absolutorium, but the 21 credits may not include the mandatory practice period and the thesis seminar, while for PhD students the number of credits awarded by the receiving institution abroad may not exceed the maximum number of credits specified in the Doctoral (PhD) Regulations and the rules of operation of the relevant doctoral school.
- 3.2. Other conditions of submitting the application and participating in the programme:

- 3.2.1. To be eligible for the long-term general learning mobility programme, students must have at least one (1) semester completed at the University at the start of the mobility.
- 3.2.2. In their applications, students may only select institutions that offer topic areas related to the programme affected by the application (see Annex 4 for the topic areas that may be selected for individual programmes).
- 3.2.3. Students attending more than one programme at the same time must specify in their application, from which programme they are applying for the mobility programme, and only their academic performance in relation to that programme selected that way will be taken into account in the assessment of their application, and they may select partner institutions related to this field of study only in their application.
- 3.2.4. CEMS programme institutions can be selected by students, who
 - 3.2.4.1. are attending the Management and Leadership Master programme in English, or
 - 3.2.4.2. have submitted their applications for the CEMS student positions advertised by the CEMS office on 11-22 November 2024.
- 3.2.5. A QTEM programme institution can be selected by students, who have submitted an application for a QTEM student position advertised by the QTEM office between 1 December 2024 and 6 January 2025.
- 3.2.6. In the course of learning mobility, only the following activities carried out abroad may be accepted: completion of full-time, daytime studies in a Bachelor, two-cycle or single-cycle Master or doctoral programme leading to a recognised diploma or degree. Learning mobility may be for compulsory, compulsory elective and elective subjects, but mobility programmes are not available for the sole purpose of preparing a thesis, including the completion of a thesis seminar, or for the completion of criterion subjects.
- 3.2.7. In their applications, applicants must establish a preference ranking of minimum one and maximum six institutions from among those they have chosen, indicating the topic area of the programme and the expected duration of the trip (duration of study). The order of preference and the selected period of study cannot be revised after the first step of the application process (see point 4).
- 3.2.8. Before submitting their applications, applicants must make sure that the institution they wish to apply to does not have any requirements that would prevent them from studying abroad (e.g. language examination requirements that exceed the minimum criteria, i.e. the complex B2 language examination).
- 3.2.9. It is the responsibility of the applying student to check the subjects offered by the selected universities for the period applied for and the language of instruction before submitting the application. If the subjects offered for the mobility semester are not available during the application period, information can be collected based on the subjects offered in previous semesters.
- 3.2.10. It is the student's responsibility to check the acceptance of subjects offered by the partner universities before submitting the application, in view of the fact that the subjects completed at the partner institution must be accepted at the University.

- 3.2.11. If the applicant requests that other activities included in the evaluation criteria be taken into account in his/her application, he/she must attach the relevant certificates signed by the persons specified in the RSFB, as set out in the table in Annex 1. Only documents in pdf format can be attached to the application.
- 3.2.12. If the applicant attends a double or multiple degree programme and this application is for a semester to be completed under this programme at the partner university abroad, and he/she has already been admitted to the double or multiple degree programme before the deadline for the submission of applications, he/she must attach to his/her application a document certifying his/her admission to the double or multiple degree programme.
- 3.2.13. If a student's application for admission to a double or multiple degree programme is not accepted by the closing date of this application and the student indicated in his/her application a partner institution(s) which is/are specifically available only to students attending double or multiple degree programmes, these institutions will be disregarded in the assessment.
- 3.3. In addition to the above, the following special rules apply to students attending PhD programmes:
 - 3.3.1. Students participating in PhD programmes may only apply to a partner university from which they have an official letter of acceptance or a clear written confirmation of their acceptance, agreed in advance and documented by the collaborating partner (the lecturer or researcher who is affiliated to the institution).
 - 3.3.2. They must attach to their applications a signed detailed research plan and work plan with the requirements set out in Annex 3 to this call for applications.

4. Method of submitting applications

- 4.1. The application (including the name of the institution and the application form) must be submitted in the Neptun study system as follows:
 - 4.1.1. In the first step, in the Neptun/Administration/Erasmus menu, students indicate all the institutions, the topic areas belonging to the institutions and the expected start date and duration of the studies for which they wish to apply (order of preference). A maximum of 6 institutions can be selected for this call for applications. **The interface where the institutions can be selected and the final order of preference can be determined will be open from 10:00, 20 January 2025 to 10:00, 27 January 2025.** The selection of the institutions does not constitute an application, but it is a condition for a valid application.
 - 4.1.2. In the second step, based on the order established and finalised in the previous step, students can submit their applications for the study abroad programme and for the scholarship supporting their study abroad (E401 - Application for study abroad, long-term mobility) in Neptun/Administration/Applications. **The application period is 09:00, 28 January 2025 - 15:00, 3 February 2025.** Applications may be submitted by students who have made their choice from among the eligible institutions as described in the previous point. The application is valid only for the institutions identified and ranked in accordance with the previous point.

4.1.3. **The two above activities (selection and prioritisation of institutions and submission of the application) together constitute the submission of an application according to this call for applications.**

4.1.4. The above deadlines are time-barred and late or incomplete applications will not be taken into account in the assessment. There is no room for correcting deficiencies or for submitting applications for justification.

5. Evaluation of applications

5.1. Applications will be rejected without examining the merits from students who:

5.1.1. are not eligible to submit a application under the criteria set out in point 3;

5.1.2. if the student did not attach the mandatory document indicated as a condition for the submission of the application, or did not attach it in accordance with the content or form of the call for applications. It is the student's responsibility to check that the uploaded document is not damaged and can be opened.

5.1.3. The student has not completed one of the activities under point 4 (selection of institutions and definition of order of preference and submission of application).

5.2. If the applicant does not provide the required certification for an activity specified in the call for applications, or does not provide it in accordance with the content or form specified in the call for applications, or if it is technically incorrect (e.g. the file cannot be opened), the given activity will not be evaluated, but the other elements of the application - if they are certified in accordance with the rules of the call for applications - will be evaluated.

5.3. Submitted applications will be assessed on the basis of the criteria set out in this section and in Annex 1 for students attending Bachelor programmes and two-cycle and single-cycle Master programmes:

5.4. For PhD students, the assessment will follow the rules set out in Annex 2.

5.5. If a student applies for mobility in the 2025/2026 academic year under the Excellence Scholarship Programme, too, in addition to this call for applications, and is awarded a trip to the priority partner university selected by him/her, and wins the related financial support, he/she will not be eligible for travel and scholarship for his/her application (long-term mobility) submitted under this call - then this application will be considered invalid.

5.6. Applicants who provide false or untrue information or make false or untrue declarations during the application procedure will be disqualified.

6. Ranking of applications

6.1. The currently available resources are allocated according to the following principles:

6.1.1. Students participating in CEMS and QTEM programmes have priority over other students, up to the amount available.

6.1.2. CEMS and QTEM students are followed by students admitted to double or multiple degree programmes in the order of their number of points in the present call and subject to the amount available.

6.1.3. Following the students specified in the previous two points, students travelling to partners in the current Pannonia Scholarship Programme partner countries will have priority over students travelling to other bilateral partners not eligible for financing from Pannonia Scholarships.

- 6.1.4. The remaining amount will be awarded to students based on their number of points collected in this call for applications, up to the amount available.
- 6.1.5. In the case of identical number of points, students with better academic performances (cumulative adjusted credit index) will receive grants.
- 6.2. In the case of withdrawal, the grant will be awarded to the next student in the order of priority (e.g. in the case of withdrawal from a place in Germany, the next applicant with the highest number of points travelling to Germany).
 - 6.2.1. Taking into account the aggregated number of points, the preference order indicated by the applicants and the rules of ranking, the decision on the places of study abroad and the funding opportunities is taken by the Head of the International Mobility Programmes, who will issue his/her decision in a resolution.
 - 6.2.2. The applicant must accept the higher education institution awarded on the basis of his/her number of points and preference list.

WARNING! Applicants should be aware that the Pannonia Scholarship Programme and other available scholarships cover only part of the actual expenses incurred, the difference must be covered by the student.

7. Legal remedy

- 7.1. Applicants have the right to appeal against the decision of the Head of the International Mobility Programmes within 15 days from the date of notification or, failing that, from the date of learning about the decision, in accordance with Sections 57-58 of Act CCIV of 2011 on National Higher Education. Legal remedy requests must be submitted through Neptun, addressed to the Student Appeals Committee.
- 7.2. The Student Appeals Committee will make a decision about the request for legal remedy in a procedure conducted according to the Procedure for the Assessment of First Instance Applications and Legal Remedy Requests in Relation to Student Status (hereinafter: SSP).
- 7.3. The period of administration is thirty (30) days, which does not include the periods specified in subsection 15 (3) of the SSP, especially the period in which administration at university level is suspended (i.e. the period of university shutdown).

8. Extension of the mobility period, multiple participation in a mobility programme

- 8.1. The extension of the mobility period is possible for those who still need to complete at least 21 credits in the extended mobility period to obtain the absolutorium, within the 2025/2026 academic year, at the same higher education institution or at different institutions, for participation in multiple successive mobility programmes, subject to the rules of the Pannonia Scholarship Programme and the RSA. The minimum number of 21 credits does not include: compulsory practice period, thesis seminar, and subjects taken at the University during the semester of the study abroad under a preferential study schedule.
- 8.2. For extensions or additional semester(s) at another university, the rules for the first semester abroad apply. The extension must be requested in Neptun before the start of the extension, but no later than 1 October 2025.

- 8.3. Under this call for applications, applicants can apply for both the autumn and spring semesters of the 2025/2026 academic year, regardless of whether they wish to spend the two semesters at the same or different higher education institution(s). In this case, their application will first be assessed for the semester that is at the top of their preference list.
- 8.4. Applications for the other semester will be considered subject to the availability of places, after the applications of students applying exclusively for that semester have been assessed.

Annex 1 Rules for the assessment of applications for learning mobility programmes for students in Bachelor and two-cycle and single-cycle Master programmes

Applications for mobility programmes are assessed on a scale of 1 to 100 points as follows.

- (1) Academic performance (maximum 70 points): assessed on the basis of the cumulative adjusted credit index of the programme affected by the application,
- (2) Other activity (maximum 30 points)

Other professional activities (maximum 30 points) are assessed as follows:

I. Aggregation of the

- a) Points collected from scientific activity (maximum 19 points)
- b) Points collected from teaching assistant activity (maximum 10 points)
- c) Points collected from public affairs and student association activities (maximum 15 points)
- d) Points obtained for participation in programmes to support the integration of foreign students, but maximum 6 points

- II. 60% of the total points (maximum 50 points) obtained according to point I.) will give the points obtained from other professional activity (maximum 30 points).

e) Other requirements

- a) Other professional activities of applicants attending Bachelor programmes - in relation to their Bachelor programmes affected by the call for applications - and of applicants attending Master programmes - in relation to their Bachelor programmes preceding their Master programmes - must be assessed as set out in the table below. Each activity must be supported by appropriate certifying documents (even if carried out at another higher education institution) - no points will be awarded if these are not provided.
- b) If the student is actively involved in a student association or a college for advanced studies in the semester of his/her application, the accreditation category of the student association or college for advanced studies valid from 1 January 2025 will be taken into account.
- c) If the organisation does not exist/is not accredited at the time of submitting the application, the most recent category won will be taken into account, provided that the student was already an active member at that time.
- d) If the student refers to a previous activity (but not older than 5 years), the category to which the student association belonged at the end of the student's active activity will be taken into account, if that can be supported with a retrospective certification of the activity.
- e) If the student is attending a Master programme, the activities during the Bachelor programme are also worth points. If the student has not been a member of a student association or the SU accredited at the Corvinus University of Budapest, he/she can receive points for his/her past certified activities based on category B1.
