The Higher Education Institution will not be charged any service service fee for this procedure.

An administrative action against this decision may be brought within 30 days of its notification. The application must be addressed to the competent court having jurisdiction for the place where the plaintiff's registered seat is located, but must be submitted to the Educational Authority. The fee for administrative proceedings is HUF 30,000,-, but the client is entitled to the right for the suspension of payment of duties.

GROUNDS FOR THE DECISION

As a result of the amendment to Section 16 (3) and Section 67 (5) of Act CCIV of 2011 on National Higher Education and the repeal of subparagraph c) of paragraph 2 of Part I of Annex 2 thereto, from 28 February 2025, the programmes that may be announced by the Higher Education Institution will not be authorised, but only registered. In this context, and subject to subparagraphs a) and d) of paragraph 2 of Part I of Annex 2, the operating authorisation does not specify the programmes that may be announced by the Higher Education Institution, but only the academic level of the programmes, the field of study, and in the case of doctoral programmes, the field of science and the discipline (discipline of art).

In view of this, I have amended the operating authorisation of the Higher Education Institution.

Legislation on which the decision is based: subparagraphs a) and d) of paragraph 2 of Part I of Annex 2 of Act CCIV of 2011 on National Higher Education;

I have established my powers on the basis of Section 67 of Act CCIV of 2011 on National Higher Education as well as Section 16(1) of Govt. Decree 121/2013 (26 April) on the Educational Authority. The information on legal remedy is governed by Sections 112 and 114 of the Ákr. as well as Section 39(1) of Act I of 2017 on the Code of Administrative Litigation. The duty on administrative court proceedings is governed by Section 45/A of Act XCIII of 1990 on Duties. The right for the suspension of payment of duties is governed by Section 62(1)h) of Act XCIII of 1990 on Duties.
